Testing Terms and Conditions

The Ice House of NJ Figure Skating Club arranges test sessions as a service to skaters under the following terms and conditions. Test requests will be honored according to the Club's ability to secure appropriate judges. Dance tests must be requested at least one month in advance. Tests requiring a panel of gold judges will be conducted only if a panel can be arranged for the test date. All applications must be mailed.

Application Filing Dates

1. **Club Member Registration Postmark Dates:** Priority for testing will be given in the following order for applications postmarked **between February 17, 2012 – March 15, 2012:** (1) Ice House of NJ FSC home club members on a first-come first-served basis, (2) Ice House of NJ FSC associate members.
Note: Skater must have been a member of the IHNJFSC as of July 1, 2011.
2. **Open Registration Postmark Dates:** If space is still available, test applications will be accepted on a first-come first-served basis regardless of membership for applications postmarked February 24, 2012 – March 15, 2012. Please observe postmark dates.
3. **The closing postmark date for applications is February 11, 2012.** Applications mailed after March 15, 2012 will only be accepted if test time is available.

Refunds

1. **No refunds** will be issued after a test is scheduled.
2. Refunds will be issued **only** if the club is unable to provide a requested test.
3. If an applicant registers for a moves-in-the-field test and a free skating test dependent on passing that moves-in-the-field test, **no refunds** will be issued for the free skating test if the applicant receives a retry on the moves-in-the-field-test.

In the event of an elective withdrawal from the test, please call at least 48 hours in advance of the test date. No refunds will be given in the event of an elective withdrawal.
